We added new real estate mortgage loans, new member account statement format for comprehensive and detailed summary of accounts and rebranding and creation of our credit union logo which took a modern approach to incorporate the elements of what makes Garden Island FCU today.

## For the year 2021:

- Total Assets increased by more than \$11.3 million (10.4%)

- Total Shares increased by more than \$10.9 million (11.7%)

# **Supervisory Committee Report**

The Supervisory Committee is comprised of three volunteer members appointed by the Board of Directors to ensure financial records are in order and internal controls are in place to safeguard the assets of the Credit Union and the Credit Union Members. To assure these tasks are carried out, the committee retained the services of CU Pacific Audit Solutions to develop a three-year audit plan for the years 2022 thru 2024 to address the following areas with annual audits, Automated Clearing House Audit, Safe Act Audit, Bank Secrecy Act Audit, Member Verification Audit, and Supervisory Audit.

Review of past audit reports and findings indicate that the Garden Island Federal Credit Union is financially sound, maintains accountability of its financial and lending records and possesses sound management practices. The latest NCUA Examination Report as of May 30, 2021 was a clean audit with no Findings and ZERO Documents of Resolutions. This was due to the excellent work produced by the management and staff of the Credit Union.

The Supervisory Committee would like to thank the Board of Directors, Management and Staff whose hard work, diligence and professionalism helped to maintain the safety and soundness of your credit union.
